## Minutes of South Toledo Bend Water Board March 10, 2015

Board Members Present: Dianne Lampman, Robert Marshall, Rodney DeRouen and Malcolm Franks, Geri Alford and Megan Quinn

Others Present: Tom Harless, Don Kelly, Rick Leonard, Jennifer Hawkins, and Ryan with Johnson, Thomas and Cunningham

Meeting was called to order at 8:57 AM by Mrs. Lampman. The roll was called and there was a quorum to conduct business. An opening prayer was said by Geri Alford.

There was no one present who wished to address the Board.

A motion was made by Geri Alford, second by Rodney DeRouen to amend the agenda moving item 16 up to 4A. Motion carried unanimously.

A motion was made by Geri Alford, duly seconded by Rodney DeRouen to enter into executive session. Motion carried unanimously. Board entered in to executive session.

A motion was made by Geri Alford, duly seconded by Rodney DeRouen to return from executive session. Motion carried unanimously. No action was taken while in executive session.

The Minutes of the February 10, 2015 meeting were brought to floor for approval. <u>A motion was made by Malcolm Franks, duly seconded by Robert Marshall approving the minutes as presented. Motion carried unanimously.</u>

Geri Alford presented the Treasurer's report for the month ending February 28, 2015. Checks #012809-#012841 were written. The total monthly expenses were \$35,583.05 which included checks written and bank drafts. After discussion, <u>a motion was made by Bob Marshall</u>, seconded by Rodney DeRouen to accept the Treasurer's report as presented, motion carried unanimously.

#### **OLD BUSINESS:**

Mrs. Lampman gave an update to the Board.

- CWEF Application for \$250,000 emergency funding was sent to Sabine Parish Police Jury and Ron Busby forwarded it to the state for review.
- Completed the 2014 Louisiana Water use Survey and mailed to the state.
- On 2-23-15 a letter was sent to John Richard with Facility Planning and Control regarding the auto meter project.
- Ad for bids will be placed in the Sabine Index on 3-18; 3-25; and 4-1 with bids due at the water plant by 9:00 a.m. on April 14<sup>th</sup>, 2015 for opening of the bids.
- Mrs. Lampman addressed the board, stating it has been a pleasure to serve the STBWD as president for the past 7 ½ years.
- Malcolm Franks gave a brief update of the meter project.

#### **NEW BUSINESS:**

A motion was made by Robert Marshall, duly seconded by Rodney DeRouen to adopt a resolution to set aside funds for water distribution system improvement including water meters. Resolution read aloud by Geri Alford, motion carried unanimously.

<u>A motion as made by Malcolm Franks, duly seconded by Robert Marshall adopting a resolution to advertise for bids for the Water</u> distribution System Improvements including water meters project. Resolution read aloud by Geri Alford, motion carried unanimously.

Jennifer Hawkins, CPA with Johnson, Thomas and Cunningham presented the yearly audit for fiscal year October 1, 2013 thru September 30, 2014. <u>A motion was made by Geri Alford, duly seconded by Malcolm Franks approving the audit findings as presented.</u>
<u>Motion carried unanimously.</u>

Mr. Gary Steinke present to the board the Financial Report for the 1<sup>st</sup> quarter Oct. 1, 014 thru Dec. 31, 2014. <u>A motion was made by Geri Alford, duly seconded by Rodney DeRouen to accept the financial report as presented. Motion carried unanimously.</u>

A motion was made by Geri Alford, duly seconded by Robert Marshall naming Malcolm Franks as the new board president for the South Toledo Bend Water District. Motion carried unanimously.

A motion was made by Geri Alford, duly seconded by Rodney DeRouen adopting a resolution to pay Malcom Franks, Board President of STBWD pursuant to Louisiana revised Statute 33:3817. Resolution read aloud by Geri Alford. Motion carried unanimously.

A motion was made by Robert Marshall, duly seconded by Rodney DeRouen removing Dianne Lampman signatory from all bank accounts and adding Megan Quinn. Motion carried unanimously
